Biodiversity Restoration and Conservation Policy

SCG Chemicals Public Company Limited is aware of the importance of responsible business operations in

order to achieve sustainable development. Therefore, the company has established Biodiversity Restoration and

Conservation Policy as a guideline, and committed to incorporating the consideration of impacts of biodiversity into

business decision- making processes, including promoting the restoration and conservation of biodiversity Actions

that create a Net Positive Impact (NPI) balance and No Net Loss (NNL) to biodiversity within manageable limits to

eliminate the risk and/or mitigate risks that may have a negative impact on sensitive biological values.

The policy outlined herewith shall be applied to all production operations, business facilities, business

partners in value chain: from designing, procuring, manufacturing, providing services and solutions, distribution

and logistics, and management of waste and end of used products. This policy shall also be applied to suppliers,

contractors and service providers both tier-1 and 2 suppliers and wholesalers other key business partners such as

non-managed operations, joint venture partners, outsourcing partners, new project, modification project, due-

diligence, mergers and acquisitions both Thailand and overseas as follows:

1. Commit to practice and operate with regard to biodiversity conservation: no net deforestation and no gross

deforestation in areas that are important for national and international biodiversity, such as protected areas,

reserved forest area, wetland site designated to be of international importance (Ramsar Wetlands),

National Protected Areas, World Heritage Areas, and IUCN Category I-IV Protected Areas. etc.

2. Collaborate with national and international agencies and networks for conducting business to achieve the

Sustainable Development Goals (SDGs) by establishing preventive measures and solutions for

environmental and social impacts according to biodiversity management, including avoidance,

minimization, rehabilitation & restoration, and offset.

Allocate budgets to support biodiversity restoration and conservation plans, both within and outside SCG

Chemicals including the expansion of the project to increase green area in order to promote the habitats

of plants and animals in both terrestrial and aquatic ecosystems.

4. Promote and support research and development with technology to increase efficiency of creating an

ecological balance and preserving plant and animal species can be utilized sustainably.
