# **Processing Guidelines**

For extrusion of SCGC HDPE H1000PCH, it is recommended to use a screw giving good melting and mixing without excessive shear. A single or double flight PE screws have proven satisfactory and will be used with good result. For normal extrusion equipment, we suggest a melt temperature of 200 - 220 °C, and drying 80 - 90 °C for 1 - 2 hours before use.
